

TERMS AND CONDITIONS

These Terms and Conditions apply to all participants (attendees, speakers, sponsors, exhibitors) of the NDTCS-2021 workshop to be held in Minsk, Belarus, on October 28-29, 2021 (hereafter referred to as "the conference"), which is organized by Belarusian State University of Informatics and Radioelectronics (hereafter referred to as "the conference organizer").

Registration and payment

Submission of an online registration is regarded as a firm booking and acceptance of these terms and conditions, however the booking will not be confirmed until full payment has been received. Conference fees must be paid in USD (by foreign participants) or Belarusian Ruble (by local participants) before the registration deadlines. All remittance advices should contain the participant's full name and the event name 'NDTCS-2021' and should be sent to ndtcs2021@gmail.com by 20 October 2021, otherwise registrations will be considered unpaid and therefore such bookings will be cancelled.

The conference organizer should receive the exact amount of conference fees. All transfer charges must be met by the sender. A confirmation of payment will be sent by e-mail once the transaction has been successfully processed. In the event that full payment is not received by the first conference day, the delegate will be refused entry to the conference. Payments are accepted by credit and/or debit card via online payment system and by bank transfer.

Changes

The conference organizer reserves the right to make alterations to the program, venue and timings at any time without prior notice. In the event of it being found necessary, for whatever reason, that the workshop is being postponed or the dates being changed, the organizer shall not be liable for any expenditure, damage or loss incurred by the delegate.

Registration name change may be made at any time. If any participant wishes to substitute him/herself by another delegate, s/he must notify the organizer in writing at the earliest opportunity and at least 24 hours before the event begins.

Cancellation policy

Notification of cancellation must be made in writing and sent to ndtcs2021@gmail.com. If the written notification of cancellation is received before 1 October 2021, 50 % of the paid conference fee will be refunded. No refunds will be made for cancellations received after this date as well as in the case of no show at the conference. Credit will not be given for unattended events or early termination of attendance. In the event that the conference cannot be held or is postponed due to events beyond the control of the conference organizer (Force Majeure) or due to events which are not attributable to wrongful intent or gross negligence of the conference organizer, the conference organizer cannot be held liable by participants for

any damages, costs, or losses incurred, such as transportation costs, accommodation costs, financial losses, etc. Under these circumstances, the conference organizer reserves the right to either retain the entire conference fee and to use it for a future conference, or to reimburse the participant after deducting costs already incurred for the organization of the conference and which could not be recovered from third parties.

Data protection

By registering for this conference the participants agree that the conference organizer may use their personal information to contact them by email in order to supply information relevant to this conference, or about other conferences, events and opportunities that the organizer are planning and feel may be of interest to them. The organizer may also share the participants' information with its partners and event sponsors in order for them to contact the delegates about other products and services which may be of interest to the delegates. If you do not want your details to be used in this way, please inform the conference organizer about it.

For promotional purposes, photos and video recordings will be taken during the conference. The conference organizer may then include any of these photographs and/or video footage on any of its websites, social media and/or other promotional materials, at its discretion. Delegates who do not wish to be filmed or recorded should advise the organizers in writing prior to the event.

Liability

Views expressed by speakers, sponsors and/or exhibitors are their own. The organizer shall not be held liable for any advice given, or views expressed, by any speaker, sponsor and/or exhibitor at the conference or in any material provided to the delegates. In addition, the organizer shall not be responsible or liable for any direct or indirect loss or damage of any sort incurred before, during or after the event (any expense, loss, damage, personal injury, including loss of life, disability, property damage, or property theft or actions of any kind). It is the responsibility of the delegate to arrange appropriate insurance cover in connection with their attendance at the conference.
